## Station Topic: What do you think are the biggest Behavioral Health Needs in our community that The Right Door should be addressing?

- Substance Use/Abuse
  - o recovery treatment centers
  - o Streamlining information of supports available.
  - o Detox lack of county resource, hard to find one with availability.
  - Waiting lists
  - o Needle Exchange Program
  - o Local drop off for controlled meds that are unused.
  - More recovery coaches
- Presentations in the community to build awareness. Families don't know what The Right Door can provide.
- Transportation resources lacking
- Mental Health/Physical health integration
- Homelessness needs
- Homeless Shelter needed
- Primary Care Coordination
- Mental Health and School services
- More Healthy Relationships Education
- Better communication in transition from school to Community Health Services 26 year olds from families with child with a DD
- Mental Health Court/Jail diversion continued provision needed.

## Station Topic: What trends, problems or issues have you identified in our community that we should be aware of?

- Housing no homeless shelters, no post-incarceration shelters or recovery housing available in county.
- Homeless Shelters
- Transportation lack of availability.
- Children losing Medicaid upon removal from home.
- Limited resources for inmates upon re-entry to community.
- Job Development and training needs.
- Housing Assistance Funds Used to receive from DHHS.
- Limited affordable activities for youth.
- Agencies don't collaborate enough.
- Current substance use throughout county.
- Need needle exchange.
- Financial concerns when people are on parole. Don't have a lot of money to finance all the requirements of parole.
- Single parent support for those caring for children diagnosed with Developmental Disability
- The ones you know need help teach people how to help them.

## Station Topic: What do you think are the barriers for people accessing our services?

- Available Transportation
- Available Childcare
- Stigma
- People cannot afford services and do to not qualify for Medicaid but unable to afford other insurance.
- Emergency Room Communication/Coordination

## Station Topic: How can The Right Door be more culturally competent?

- Farm season difficulty in making appointments/hours work.
- LGBTQ Friendly signage
- Cultural competency training for providers should be simplified
- More consumer representation on the board; minorities, LGBTQ, Multi-generational representation
- Outreach to Migrant community
- Identify Hispanic and Latino communities
- Outreach to farm workers dairy and seasonal

- Supports for differing family systems: Blended, single, interracial families, relatives raising relatives.
- Senior citizen outreach
- Continue providing Trauma Informed Care
- Better understanding on what the county Veteran Service Officers do.
- Move from term consumer to person served.
- Recognizing current substance use issues
  - o Lack of treatment
  - o No homeless shelter
- Cell phones and lack of engagement, isolation, communication with outside world.
- Know the prison system better.
