Gretchen Nyland presented the MSHN report, noting some changes within MSHN, and discussed Senator Stabenow's support of CCBHC as well as the status of Senator Shirkey's bills.

13. CMHA Report

Clinton Galloway informed the Board that the Board Association has sold its building which was in process before COVID-19. The building was purchased by Ingham County Court; CMHA must be out by June 1.

14. CEO Report

CEO Possehn provided an update on the status of Senate Bills 597/598 with Senator Shirkey calling for a vote soon. FY 23 budget is being worked on. CEO Possehn informed the Board that the CMHA advocacy campaign is in full force with the public mental health system and accessibility as the primary focus. She also informed the Board that Samaritas is fully staffed and ready to provide SUD services. CEO Possehn noted that the agency has had an increase in services overall, especially children's services, since January 2022 due to the CCBHC expansion. Discussion was held regarding the increase compared to other agencies within the region.

15. Other

Board Chairperson McPeek-McFadden followed up on the status of the updated agency website. Nancy Patera inquired about the Mental Health Art gallery held on May 20 in Saranac. Teresa Martin and Julie Dowling were able to report that there was low attendance, but the event was impressive with a very talented artist.
