Melissa McKinstry informed that CMHA continues to discuss strategies to stop the procurement process for the PIHP re-bids. CMHA continues to encourage advocates to contact elected officials to retain the public mental health system vs. privatization. Melissa encouraged Board members to contact elected officials and for the members to encourage others to do so as well.

13. CEO Report

CEO Possehn updated the Board on the status of the PIHP re-bid process. The official RFP is to be published this summer. CMHA representatives have met with MDHHS Director Hertel and Governor Whitmer regarding the possibility of the RFP being rescinded. CEO Possehn informed the Board that CMHA continues to develop strategies to fight the RFP and attempts at privatization of the local CMH system. She will keep the board updated.

CEO Possehn also informed the board the Mental Health Framework is to be implemented by MDHHS by October 2026. The Framework would shift some services to be provided by health plans. CMHA and the public mental health system are in opposition and developing a strategy to stop the Framework from being implemented.

CCBHC funds will be directly paid to the CCBHC as of October 1st. The Right Door is prepared for this to begin.

14. Other

Board Member McKinstry informed the Board there is an event "Breaking Barriers" coordinated by Michigan DD Council on Tuesday, July 29 starting at 2 p.m. on the State

Capital lawn and ending with a "sensory friendly" Lugnuts baseball game which begins at 7 p.m.
